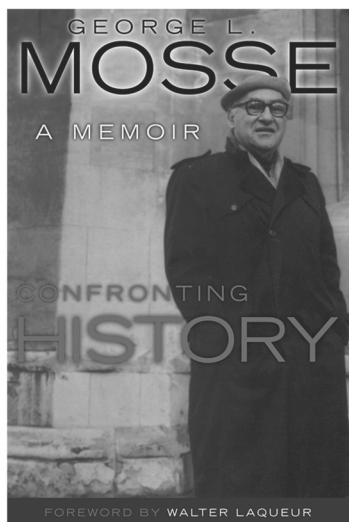

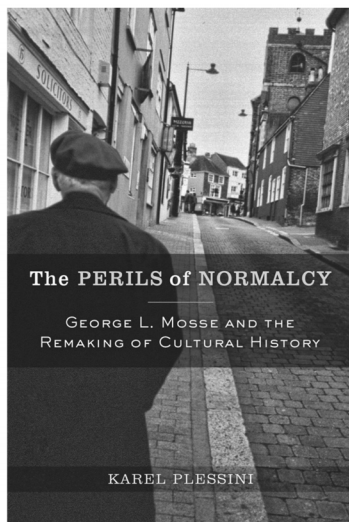

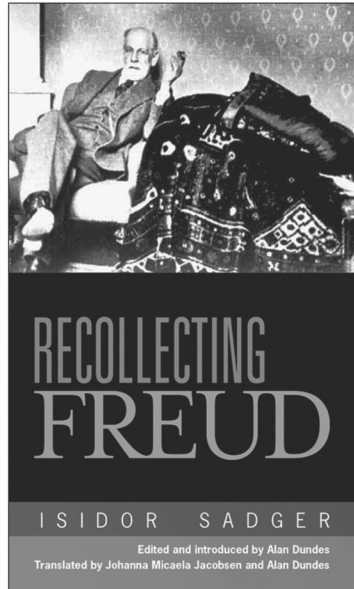
## New in Paperback
